**OFFICIAL RULES**

1. **HOW TO ENTER:** The contest begins at 8:00 AM on October 1, 2017 and ends at 11:59 PM ET on, October 31, 2017. There are two ways to enter the contest:

1.1.1. Do any or all of the following at least once during the month of October to earn up to 3 entries into the drawing.

- Earn 1 entry- Sign up for Bill Pay and pay a bill.
- Earn 2 entries- Use the Mobile app to pay a bill for the first time.

1.1.2. Free Entry. 2. **NUMBER OF ENTRIES:** There is a limit of 3 entries per account.

3. **SPONSOR:** 360 Federal Credit Union, P.O. Box 273, Windsor Locks, CT 06096.

4. **DRAWING, NOTIFICATION AND IDENTIFICATION OF WINNERS:** Prize winners will be selected by a random drawing by Sponsor at Sponsor’s office located at 191 Ella Grasso Turnpike, Windsor Locks CT 06096 on Friday, November 10, 2017 from all eligible entries received. Winner need not be present to win. Winner will be notified by phone or e-mail.

5. **NO PURCHASE NECESSARY:** Purchase will not enhance chance of winning.

6. **PRIZES:** November 10, 2017- 3 qualifying members will be selected to receive up to \$200.00 each which will be credited to their 360FCU 00 suffix.
